This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

**Application of Katherine Klein and John Gomperts**, pursuant to 11 DCMR § 3103.2, for a variance from lot occupancy requirements under section 403, a variance from the rear yard requirements under section 404, and a variance from the nonconforming structure requirements under subsection 2001.3, to allow a rear deck addition to an existing one-family row dwelling in the D/R-3 District at premises 1618 22<sup>nd</sup> Street, N.W. (Square 2512, Lot 23).

The hearing will be held on Tuesday, May 1, 2011, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 P.m. and 6:00 p.m.
