Dear Advisory Neighborhood Commission 6C:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

**Application of JBG/New York Avenue Hotel LLC**, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the parking requirements under section 2101.1, a variance from the compact car parking space provisions under sections 2115.2 and 2115.4, and a special exception from the roof structure requirements under sections 411 and 770.6, to permit the development of a hotel in the C-3-C District at premises 33 New York Avenue, N.E. (Square 671, Lot 27).

The hearing will be held on Tuesday, May 8, 2012, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing. 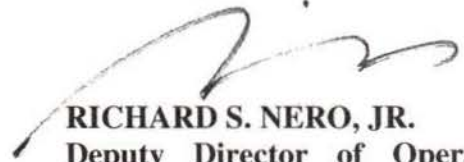
