This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Kevin and Anne MacMillan, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear garage addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403) requirements in the R-2 District at premises 2933 Tilden Street, N.W. (Square 2235, Lot 68).
