This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Wagtime, LLC, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for special exception pursuant to subsection 802.21, and a variance from subsection 801.7(a) (iii) and (a)(iv)(D), to permit an animal boarding and animal shelter use in the C-M-1 District at premises 900 M Street, S.E. (Square 952, Lot 34).

The hearing will be held on Tuesday, May 8, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.


