This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Rick and Alexis Juneja, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear garage addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403) and nonconforming structure (subsection 2001.3) requirements in the R-4 District at premises 216 7th Street, N.E. (Square 865, Lot 88).

The hearing will be held on Tuesday, May 8, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
