This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Benson D. Medley, pursuant to 11 DCMR § 3103.2, for a variance from the lot area requirements under subsection 401.11, to increase the number of dwelling units in an existing apartment house from 3 to 4 units in the R-4 District at premises 1865 Newton Street, N.W. (Square 2616, Lot 100).
