This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Arthur Marques Kalil and Lolanda Tappin, pursuant to 11 DCMR § 3103.2, for a variance from the lot area and lot width requirements under section 401, to construct a new flat (two-family dwelling) in the R-4 District at premises 1400 block of 3rd Street, N.W. (Square 553W, Lot 804).
