This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Stephen H. Greer, pursuant to 11 DCMR §§ 3104.1 and 1543.1, for a special exception to allow an addition to an existing one-family dwelling under section 223, not meeting the side yard (section 405) and nonconforming structure (subsection 2001.3) requirements in the WH/R-1-A District at premises 4626 Garfield Street, N.W. (Square 1408, Lot 800).

The hearing will be held on Tuesday, June 5, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
