This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of David E. Perkins, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the lot occupancy requirements under section 403, and a special exception to construct a free standing carport serving a one-family row dwelling under subsection 2300.8, in the R-4 District at 2014 Summit Place, N.E. (Square 3535, Lot 810).

The hearing will be held on Tuesday, June 5, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

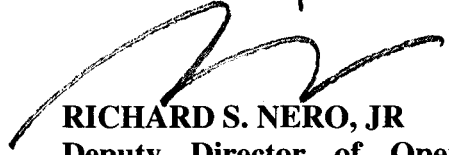
