The property involved in this application is located within the boundaries of Advisory Neighborhood Commission 2B This application will be heard between 9 30 a m and 12 00 p m

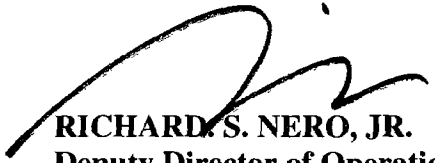
