Dear Advisory Neighborhood Commission 6B:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Barracks Row Venture LLC, pursuant to 11 DCMR § 3103.2, for a variance from the rear yard requirements under section 774 and a variance from the parking requirements for historic buildings under subsection 2120.3, to allow an addition to an existing building for retail, office and restaurant use in the CHC/C-2-A District at premises 717 8th Street, S.E. (Square 904, Lot 35).

The hearing will be held on Tuesday, June 19, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

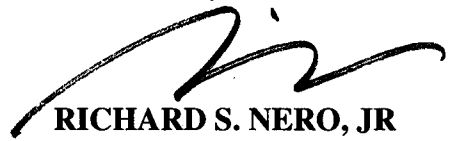
