Dear Advisory Neighborhood Commission 2F:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of CAS Riegler Real Estate Development, pursuant to 11 DCMR § 3103.2, for a variance from the height requirements under subsection 770.1, a variance from the floor area ratio requirements under subsection 2604.1, a variance from the lot occupancy requirements under subsection 2604.2, and a variance from the off-street parking requirements under subsection 2101.1, for an addition to an existing building for a mixed-use residential building with ground floor retail and the construction of a separate row dwelling in the C-2-A District at premises 1250 9th Street, N.W. and 902 N Street, N.W. (Square 368, Lots 912 and 891).

The hearing will be held on Tuesday, June 26, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
