This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Clifford S. Reese, pursuant to 11 DCMR § 3104.1, for a special exception under subsection 203.4(b), to establish a home occupation (one barber chair in the basement) in a one-family dwelling in the R-5-A District at premises 5831 Colorado Avenue, N.W. (Square 2937, Lot 837).
