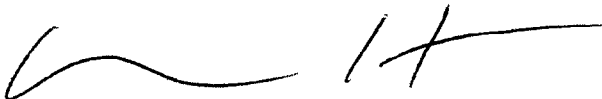
Dear Chairperson Jordan:
