Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, July 10, 2012, on the following application:

Application of Atlas District Veterinary Hospital, pursuant to 11 DCMR § 3104.1 for special exceptions from the off-street parking requirements under sections 730 and 2116.1, to establish a veterinary hospital under section 730, in the HS/C-2-A District at premises 1326 H Street, N.E. (Square 1026, Lots 86 and 832).

This application is located within the boundaries of Advisory Neighborhood Commission 6A. 5. Describe any other relevant matters that demonstrate how the person will likely be affected or aggrieved if the action requested of the Commission/Board is approved or denied.
6. Explain how the person's interest will be more significantly, distinctively, or uniquely affected in character or kind by the proposed zoning action than that of other persons in the general public.

Except for the applicant, appellant or the ANC, to participate as a party in a proceeding before the Commission/Board, any affected person shall file with the Zoning Commission or Board of Zoning Adjustment, this Form 140 not less than fourteen (14) days prior to the date set for the hearing.
