Application of Atlas District Veterinary Hospital, pursuant to 11 DCMR § 3104.1 for special exceptions from the off-street parking requirements under sections 730 and 2116.1, to establish a veterinary hospital under section 730, in the HS/C-2-A District at premises 1326 H Street, N.E.
