This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Cornelle Smith, pursuant to 11 DCMR § 3103.2, for a variance from the building height requirements under section 400, and a variance from the open court requirements under section 406, for an addition to an existing apartment building in the R-4 District at premises 3453 Holmead Place, N.W. (Square 2834, Lot 73).

- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

For Board of Zoning Adjustment:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
