This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Jeffrey Alpher and Haley Kaufman, pursuant to 11 DCMR § 3104.1, for a special exception for a rear porch addition to an existing one-family detached dwelling under section 223, not meeting the lot occupancy (section 403) and side yard (section 405) requirements in the R-1-B District at premises 2938 Macomb Street, N.W. (Square 2084, Lot 825).
