This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Gerald and Kara Morrissey, pursuant to 11 DCMR § 3104.1, for a special exception for a third floor addition to an existing one-family row dwelling under section 223, not meeting the lot area and width (section 401), lot occupancy (section 403) rear yard (section 405) and nonconforming structure (2001.3) requirements in the R-4 District at premises 423 M Street, N.E. (Square 805, Lot 74).

The hearing will be held on Tuesday, July 17, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
