This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Lawal Abdulganiyu, pursuant to 11 DCMR § 3103.2, for a variance from the lot width requirements under section 401, a variance from the side yard requirements under section 405, and a variance from the use provisions under section 201.1, to construct a semi-detached dwelling in the R-1-B District at premises 4336 Douglas Street, N.E. (Square 5116, Lot 115).
