**Application of Pony Express LLC dba EastBanc, Inc.**, pursuant to 11 DCMR § 3103.2, for a variance from the lot occupancy requirements under section 403, a variance from the rear yard requirements under section 404, a variance from the side yard requirements under section 405 and a variance from the use provisions under subsection 2002.4, to permit the renovation and expansion of an existing building for a retail, commercial and office use in the C-2-A and R-3 Districts at premises 1215 31st Street, N.W. (Square 1209, Lot 826).
