This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Pony Express LLC dba EastBanc, Inc., pursuant to 11 DCMR § 3103 2, for a variance from the lot occupancy requirements under section 403, a variance from the rear yard requirements under section 404, a variance from the side yard requirements under section 405 and a variance from the use provisions under subsection 2002 4, to permit the renovation and expansion of an existing building for a retail, commercial and office use in the C-2-A and R-3 Districts at premises 1215 31st Street, N.W. (Square 1209, Lot 826).

The hearing will be held on Tuesday, July 24, 2012, at 441 4th Street, N W , Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p m and 6:00 p.m.


