This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Barbara Chambers Children's Center, pursuant to 11 DCMR § 3104.1, for a special exception to permit the expansion (225 Children and 47 Staff) of an approved child development center (BZA Order No 17731) under section 205, in the R-5-B District at premises 1470 Irving Street, N.W. (Square 2672, Lot 881).
