This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Beverly Pringle and Mark Moran, pursuant to 11 DCMR § 3104.1, for a special exception for an addition to an existing one-family row dwelling under section 223, not meeting the open court (section 406) requirements in the R-4 District at premises 232 11th Street, N.E. (Square 964, Lot 827).
