Dear Advisory Neighborhood Commission 5B:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of St. Mary's Missionary Baptist Church, pursuant to 11 DCMR § 3103.2, for a variance from the lot occupancy requirements under section 403, a variance from the rear yard requirements under section 404, and a variance from the off-street parking requirements under subsection 2101.1, to allow an addition to an existing church in the R-1-B District at premises 2811 14th Street, N.E. (Square 4020, Lot 29).

The hearing will be held on Tuesday, September 11, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
