This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Marina Martin, pursuant to 11 DCMR §§ 3104.1 and 1202.1, for a special exception to allow a rear deck addition to an existing flat (two-family) row dwelling under section 223, not meeting the lot occupancy (section 403) requirements in the CAP/R-4 District at premises 149 D Street, S.E. (Square 734, Lot 74).

The hearing will be held on Tuesday, September 11, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
