This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Eric Schultz, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear deck and trellis addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403), rear yard (section 404), and court (section 406) requirements in the R-4 District at premises 58 Rhode Island Avenue, N.W. (Square 3111, Lot 24).

The hearing will be held on Tuesday, September 11, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
