Dear Advisory Neighborhood Commission 1B:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Florida Avenue Residential LLC, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for variances from the parking (subsection 2101.1) loading (subsection 220.1) and lot occupancy (subsection 772.1) requirements and special exceptions from the roof structure (subsection 770.6) and streetwall (subsection 1903.3) requirements to allow the development of a six-story mixed-use residential building with ground floor retail/service uses in the ARTS/C-2-B District at premises along Florida Avenue, N.W., 8th Street, N.W., and 9th Street, N.W. (Square 393, Lots 41, 44, 45, 46, and 826).

The hearing will be held on Tuesday, September 18, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
