Dear Advisory Neighborhood Commission 4C:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

**Application of Jewish Primary Day School of the Nation's Capital Inc.**, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a variance from the off-street parking requirements under subsection 2101.1, and a special exception under section 206 to increase the private school student enrollment cap from 125 to 130 students and to increase the faculty and staff cap from 15 to 26, in the R-1-B District at premises 4715 16<sup>th</sup> Street, N.W. (Square 2707, Lot 33).

The hearing will be held on Tuesday, September 25, 2012, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
