Dear Advisory Neighborhood Commission 2C:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Erin Murphy and Johanna Sears, pursuant to 11 DCMR § 3103.2, for a variance from the building on alley lot provisions under subsection 2507.1, to allow the continued use of two residential apartments in a three unit apartment building located on alley lots in the DD/R-5-B District at premises rear of 1131 5th Street, N.W. (Square 514, Lots 2214 and 2215, also known as Lots 48 through 50).

The hearing will be held on Tuesday, October 16, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
