Application of SLS Carriage House Enterprise LLC, pursuant to 11 DCMR § 3104.1, for a special exception under section 508, to permit the conversion of an existing building to office use in the DC/SP-1 District at premises 1749 and 1751 St Matthews Court, N W (Square 159, Lots 46 and 47).
