Application of Shophouse LLC, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the floor area ratio (subsection 771.2), nonconforming structure (subsection 2001.3), and rear yard (section 774) requirements and a special exception under section 733 for a fast food establishment in the C-2-A District at premises 2805 M Street, N.W. (Square 1212, Lot 802)
