This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of CAS Riegler Companies, pursuant to 11 DCMR § 3103.2, for a variance from the off-street parking requirements under subsection 2101.1, for the conversion of an existing flat into an apartment housing containing five units in the R-4 District at premises 1300 Park Road, N.W. (Square 2843, Lot 824).
