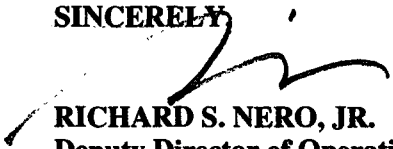

Application of Marcus A. Watkins, pursuant to 11 DCMR § 3103.2, for a variance from the lot area and lot width requirements under subsection 401.3, to allow the subdivision and construction of two new flats (two-family dwellings) in the R-4, at premises 257 Warren Street, N.E. (Square 1033, Lots 135, 136 and 137).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 6A.
