This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of David Michaels and Juliet Macur, pursuant to 11 DCMR § 3104.1, for a special exception for a rear addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403), side yard (section 405), and nonconforming structure (subsection 2001.3) requirements in the R-4 District at premises 712 A Street, S.E. (Square 898, Lot 50).

The hearing will be held on Tuesday, October 16, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

For Board of Zoning Adjustment:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
