Dear Advisory Neighborhood Commission 1B:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of PT2SO LLC, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a variance from the lot occupancy requirements under subsection 772.1, a variance from the rear yard requirements under subsection 774.7(b), and a special exception from the roof structure provisions under subsection 411.3, to allow the construction of a new mixed use nine (9) unit residential apartment house with commercial and retail service establishments in the Arts/C-2-B District at 1932 9th Street, N.W. (Square 361, Lot 134).

The hearing will be held on Tuesday, October 16, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

3. Submission deadlines are as follows:

For Zoning Commission:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing, if they wish to participate in a contested case under § 3022.
- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

For Board of Zoning Adjustment:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
