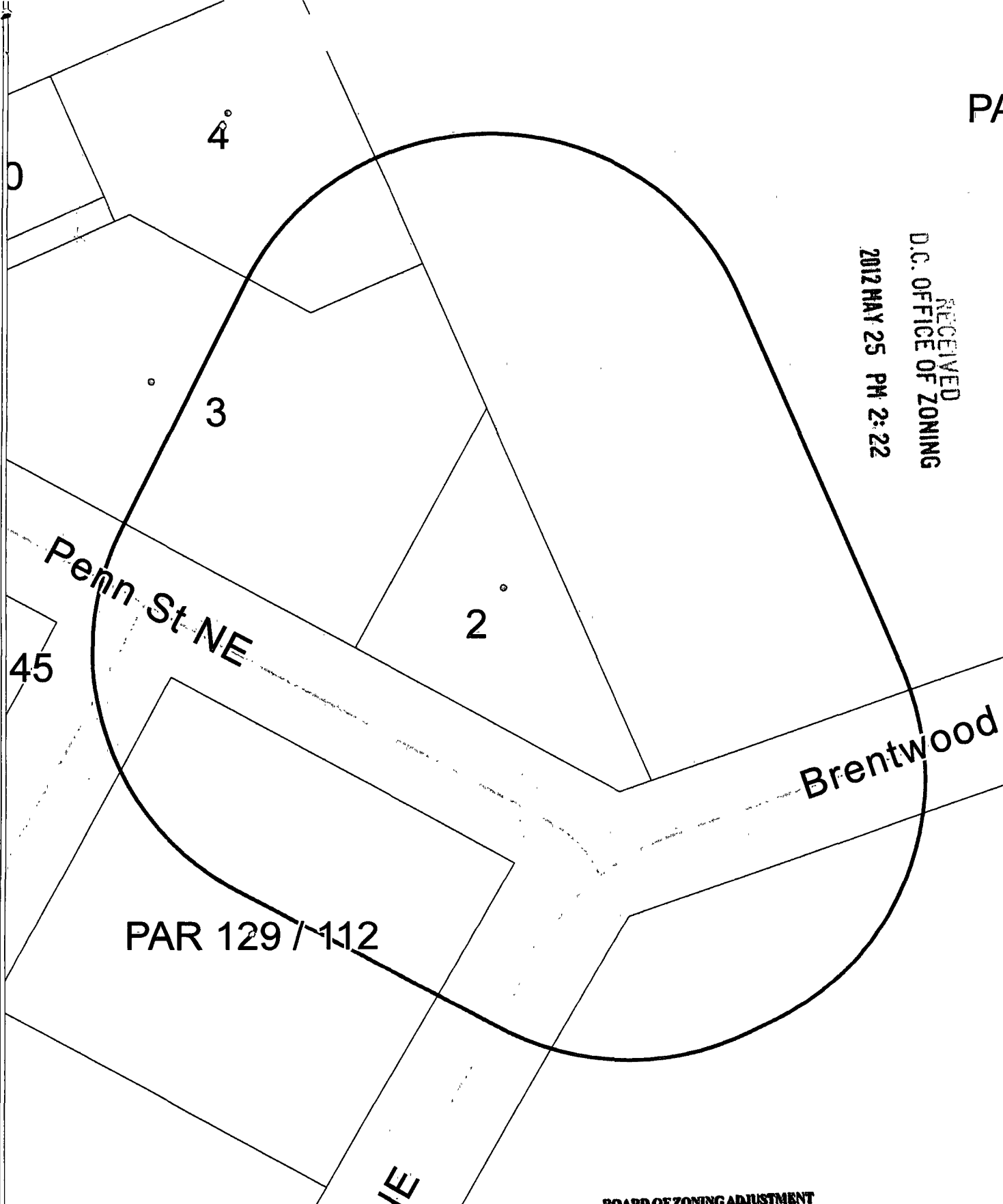

Square 3594 Lot 2

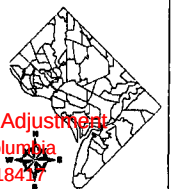
