Application of 2221 14th Street LLC, pursuant to 11 DCMR § 3103.2, for a modification of BZA Order No. 18157, to reduce the number of required parking spaces under subsection 2101.1, from ten to zero to allow the construction of a new 30 unit apartment building in the ARTS/C-3-A District at 2221 14th Street, N.W. (Square 234, Lot 165).
