This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of AT&T, pursuant to 11 DCMR § 3104.1, for a special exception to allow the installation of a 128 feet tall (lightpole) monopole, antennas and related equipment shelter and cabinets under section 2713, in the R-4 District at premises 4301 13th Street, N.W. (Roosevelt High School) (Square 2915, Lot 802).

The hearing will be held on Tuesday, October 23, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
