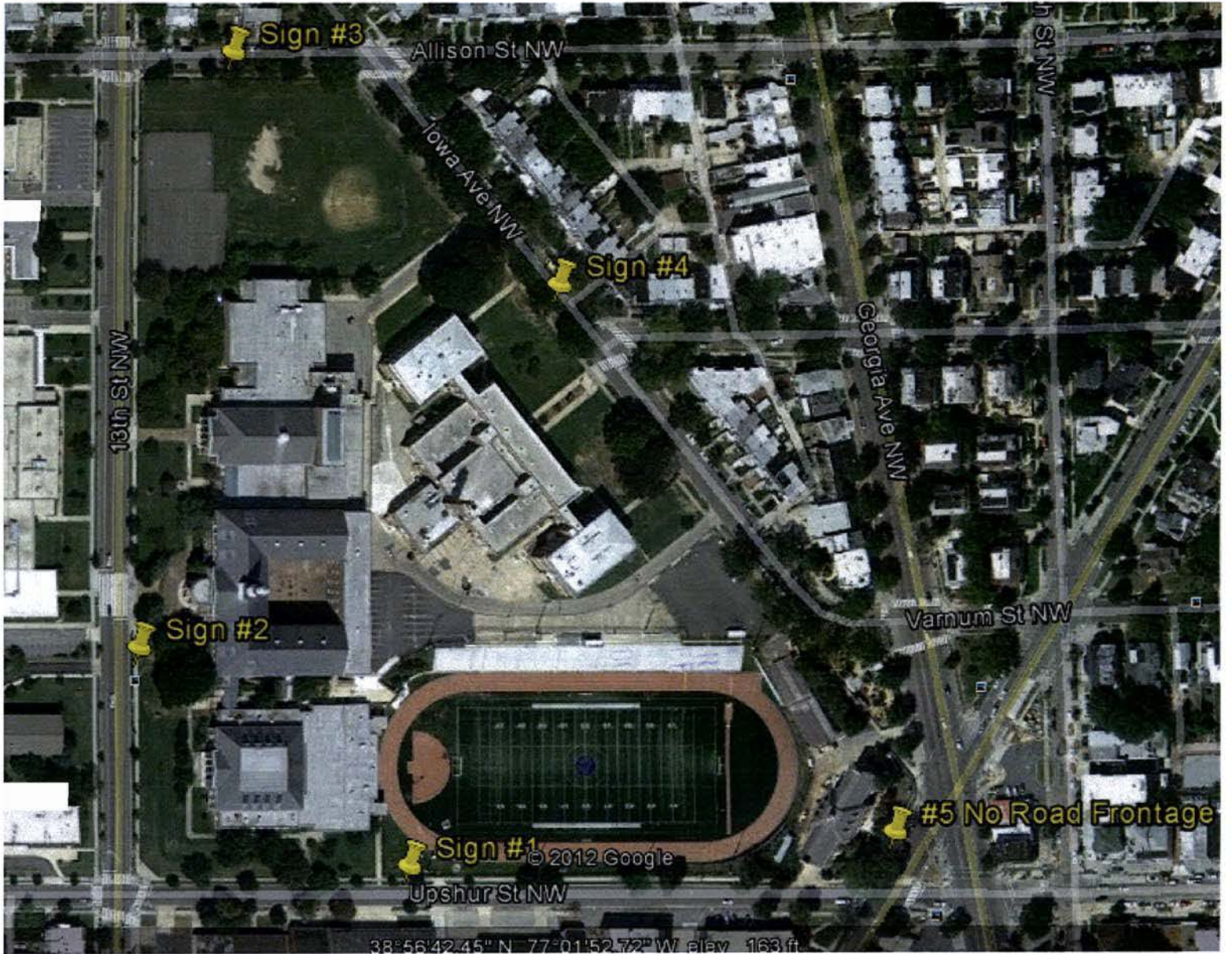

Aerial Map of Sign Locations

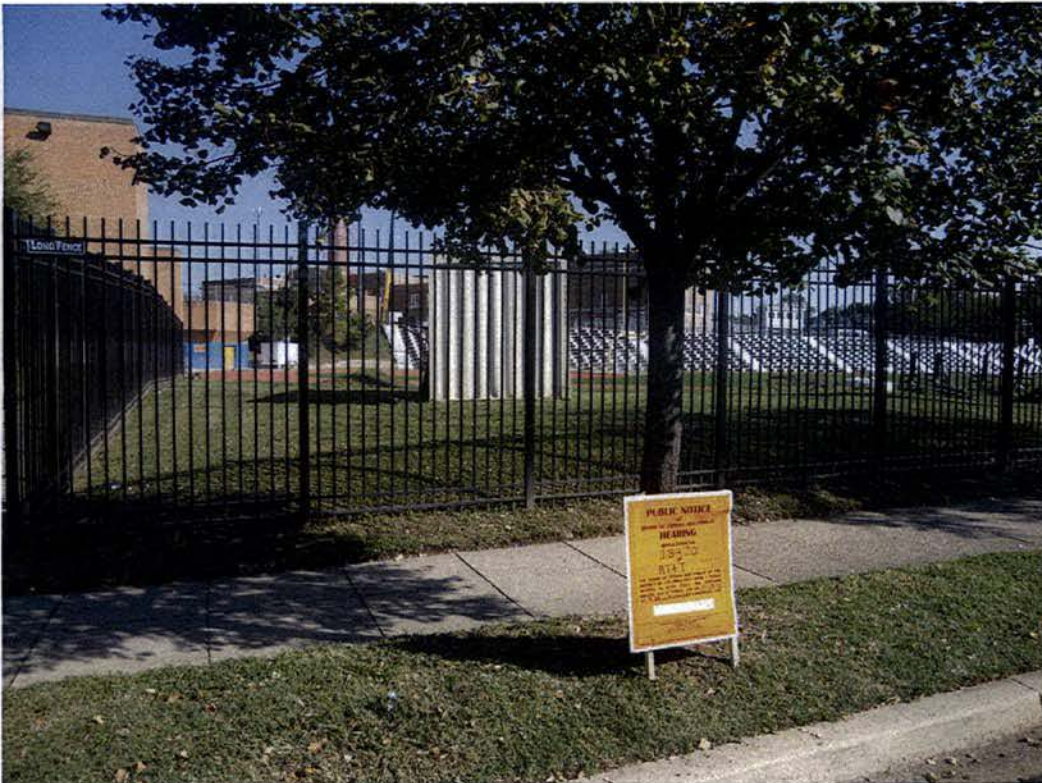
