This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of 3579 Warder Street LLC, pursuant to 11 DCMR § 3103.2, for a variance from the nonconforming structure provisions under subsection 2001.3 (not meeting the lot occupancy requirements under sections 772 and 774 respectively), and a variance from the off-street parking requirements under subsection 2101.1, to allow the renovation of an existing dwelling into a 4 unit apartment house in the R-5-D District at premises 3602 16th Street, N.W. (Square 2624, Lot 776)
