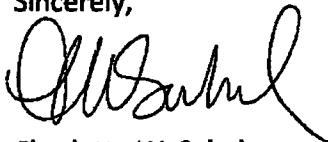

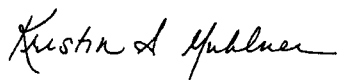
For almost forty years, Intown Playgroup has served the local community. Numerous local families have benefited from the school.
