If this application is removed, the only public notice of the hearing date will be posted in the Office of Zoning up until the date of the hearing. Except for the applicant, appellant or the ANC, to participate as a party in a proceeding before the Commission/Board, any affected person shall file with the Zoning Commission or Board of Zoning Adjustment, this Form 140 not less than fourteen (14) days prior to the date set for the hearing.
