Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, October 30, 2012, on the following application:

Application of Jomo-Oludipe pursuant to 11 DCMR § 3103.2, for variances from the lot area and lot width requirements under subsection 401.3, and a variance from the side yard requirements under section 405, to allow the new construction of two semi-detached dwellings in the R-2 District at premises 154 and 156 Forrester Street, S.W. (Square 6239, Lots 11 and 12).

All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded.
