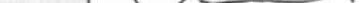

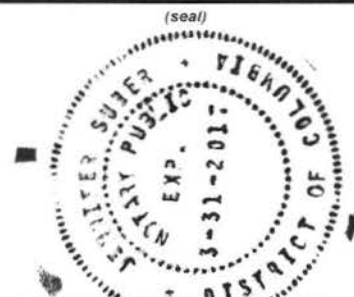

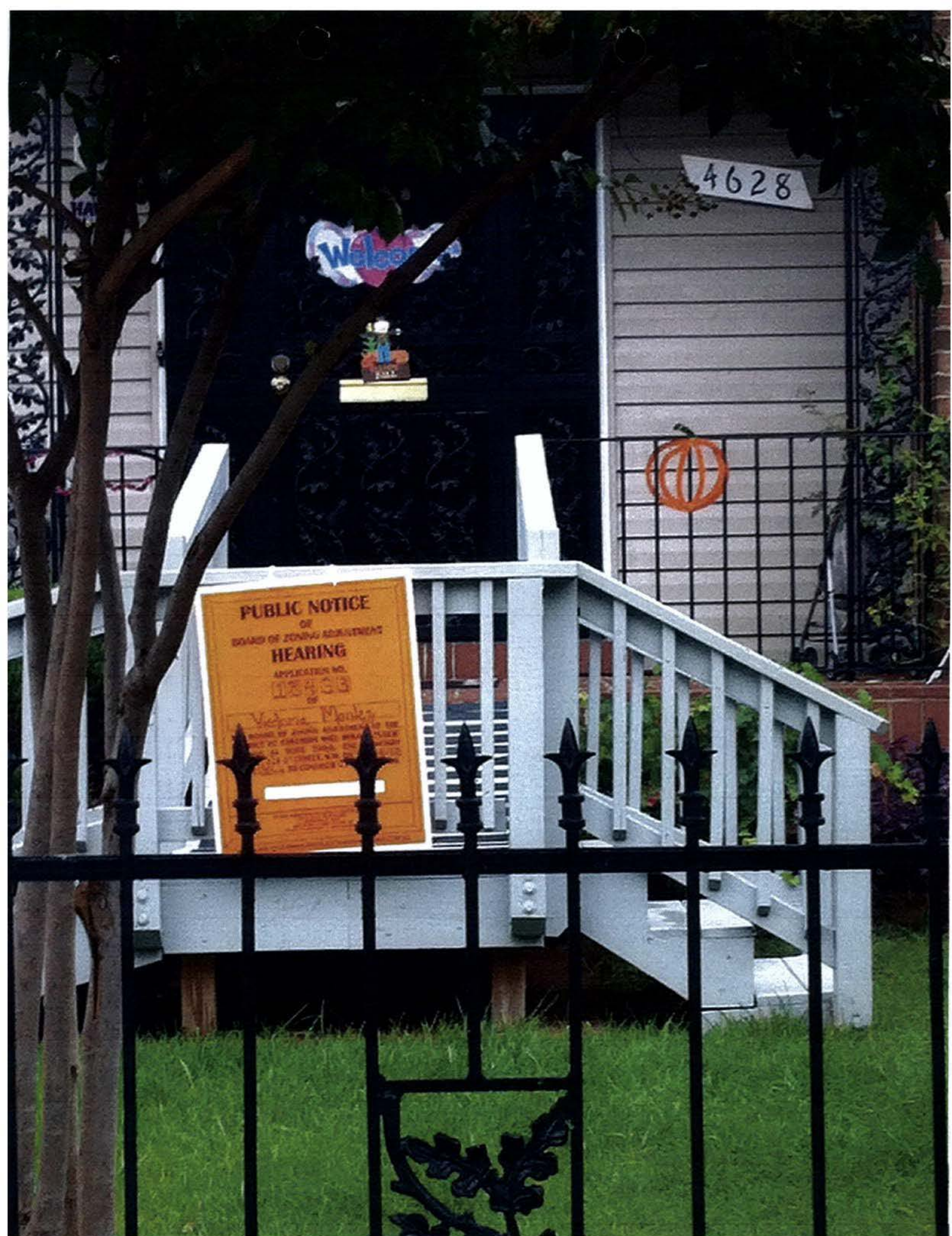
Any form that is not completed in accordance with the following instructions shall not be accepted.
