Application of David Benson, pursuant to 11 DCMR § 3103.2, for a variance from the lot area requirements under subsection 401.3, to allow the conversion of a flat (two-unit dwelling) to a three unit apartment house in the R-4 District at premises 2703 11th Street, N.W. (Square 2858, Lot 17).

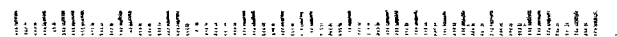
