This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of John C. Hines, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a variance from the rear yard requirements under section 404, and a special exception under subsection 2516.1, to permit an addition to an existing flat (two-family dwelling) where there are more than one principal structure on a single lot in the R-4 District at premises 1618 5th Street, N.W. (Square 477, Lot 845).

The hearing will be held on Tuesday, October 23, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
