

Application of Karen Slachetku, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear deck an existing one-family row dwelling under section 223, not meeting the lot area and width requirements (section 401), lot occupancy (section 403) and rear yard (section 404) requirements in the R-4 District at premises 1139 Abbey Place, N.E. (Square 773, Lot 193).
