Application of 3579 Warder Street LLC, pursuant to 11 DCMR § 3103.2, for a variance from the lot area requirements under subsection 401.3, to allow the conversion of a rooming house into a four (4) unit apartment building in the R-4 District at premises 1221 Otis Place, N.W. (Square 2829, Lot 57).
