Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001 on Tuesday, December 4, 2012, on the following application:

Application of Israel Baptist Church and Israel Manor Inc., pursuant to 11 DCMR § 3104.1 and 3103.2, for a variance from the parking requirements under subsection 2101.1, and a special exception under subsection 2116.3, for a community health facility and ancillary church social and recreation space to be erected as an addition to the existing church building with required on-site parking located elsewhere than on the subject property in the R-5-A District at premises 1251 Saratoga Avenue, N.E. and 2403, 2407, 2409 and 2411 12th Street, N.E. (Square 3939, Lots 31, 33, 34, 35 and 36).

At the public hearing, all interested persons will be given an opportunity to express their views. However, in lieu of appearing at the hearing you may also submit written views about this case. All written views should be sent to the address below, and must be received by the Board before the hearing on the case is concluded. Except for the affected ANC, any person who desires to participate as a party in this case must clearly demonstrate that the person's interests would likely be more significantly, distinctly, or uniquely affected by the proposed zoning action than other persons in the general public. 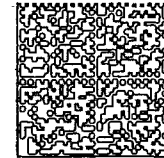
